THE WESTERN AUSTRALIAN ELECTRICITY REVIEW BOARD ORDERS THAT:

- The ERA do by 2 March 2012 recalculate the Reference Tariff ("Tariff") which GGT may charge from 1 April 2012 in accordance with the particular methodology described below. This methodology is given effect by applying clause 9.8 of the Reference Tariff Adjustment Mechanism adjustment mechanism in Schedule 1 the general terms and conditions of the Access Arrangement (and the annual adjustment mechanism prescribed in Schedule 1) to the modelled Tariff for 1 April 2012.
- The methodology used to calculate the Tariff components to be charged by GGT from 1 April 2012 shall involve the following steps:
 - (a) take the tariff produced by the tariff model for period from 1 April 2012,
 - (b) reduce this tariff by the forecast inflation across the period from 20 August 2010 to 1 April 2012, in order to obtain the starting tariff for the Access Arrangement on 20 August 2010; and
 - (c) then increase the starting tariff by reference to actual inflation and other appropriate adjustments across the period from 20 August 2010 to 1 April 2012
- Alternative calculations should be prepared on the basis of both a pro-rata and a compounding allocation of the WACC during the period 20 August to 31 December 2010.
- 4 GGT do within 7 days provide a draft clause for inclusion in the EEP dealing with prior notification to the ERA of all proposed extensions and expansions of the Pipeline.
- The other parties may, within 3 clear days thereafter, provide a version of the draft marking up any changes they consider appropriate.
- 6 There be liberty to apply.
- 7 The matter is otherwise adjourned.
