CALL FOR SUBMISSIONS - DRAFT AUDIT AND REVIEW GUIDELINES: WATER LICENCES

The Economic Regulation Authority, as the regulator responsible for administering the water licensing scheme, seeks public comment on its draft *Audit and Review Guidelines: Water Licences* (**Guidelines**).

Audit and Review Guidelines: Water Licences

The Guidelines inform licensees and external auditors about the Authority's requirements for the conduct of licence operational audits (**Audits**) and asset management system reviews (**Reviews**). For water licensees, the Guidelines will replace the *Audit Guidelines: Electricity, Gas and Water Licences*, published in August 2010.

The Guidelines only apply to water licences. There is a different legislative framework applying to Audits and Reviews of electricity and gas licences; the Authority published the *Audit and Review Guidelines: Electricity and Gas Licences* (**Energy Guidelines**) on 22 April 2014.

The Guidelines are based on the Energy Guidelines, but have been amended to reflect the Authority's role in appointing the auditors to undertake Audits and Reviews of water licences pursuant to sections 24 and 25 of the *Water Services Act 2012*. Appendix 5 of the Guidelines provides the reader with an overview of the process proposed by the Authority to regulate the conduct of water licence Audits and Reviews.

The focus of this consultation is the process through which the Authority manages Audits and Reviews, involving the appointment of the auditor, development of the audit plan and finalisation of the report on an Audit or Review.

Interested parties are invited to make submissions on the draft Guidelines by 4:00 pm (WST) on Friday 6 June 2014.
