Dear Paul,

Harvey Water requests the approval of the ERA for an extension to our area of operation. We would like to extend the northern boundary to include the area bordered by Herron Point Rd, Fishermans Rd and Coolup Rd East all in Coolup.

The reason for this request is that in early 2017 Harvey Water was approached by landowners on Dorsett Road and Gibbings Road in Waroona (please refer to our previous map from 8/11/2017). The landowners asked Harvey Water to extend the current Dorsett Road pipeline a further 11 kilometres and install a number of supply points on farm land.

The reasons for this request are:

- To ensure consistent supply of good quality non-potable water to livestock (cattle);
- To provide a source of water in times of bushfire.

We plan to construct this pipeline in December 2017 for completion by the end of January 2018. We have gained approval from the landowners in terms of pipe route, supply points and access to land. In addition to the supply points we will install a fire hydrant point for Bushfire Brigade's to have access to when required.

Harvey Water would like to extend into this area as in the future their may be demand for fit for purpose non-potable water that we could supply by further extending our infrastructure.

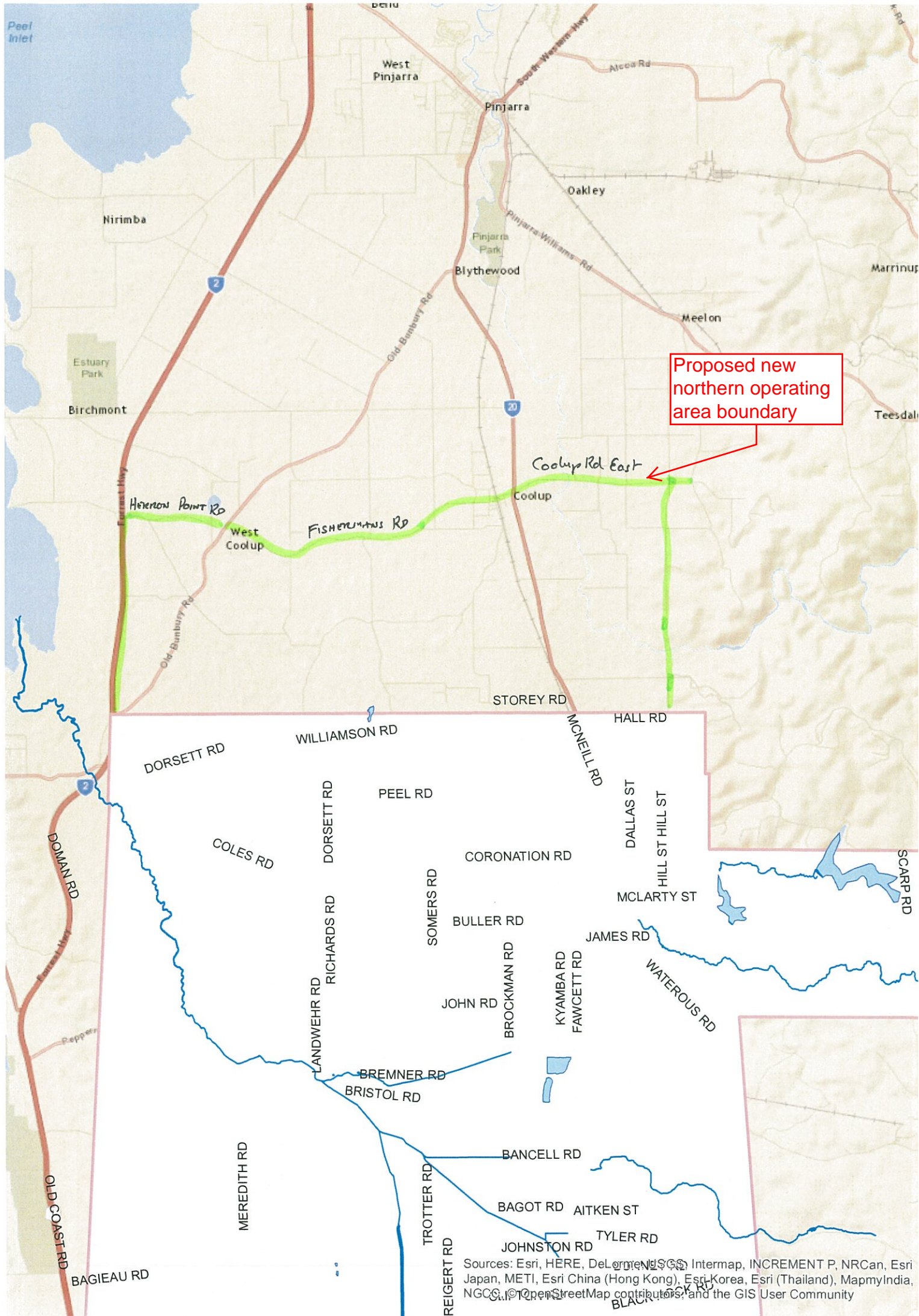

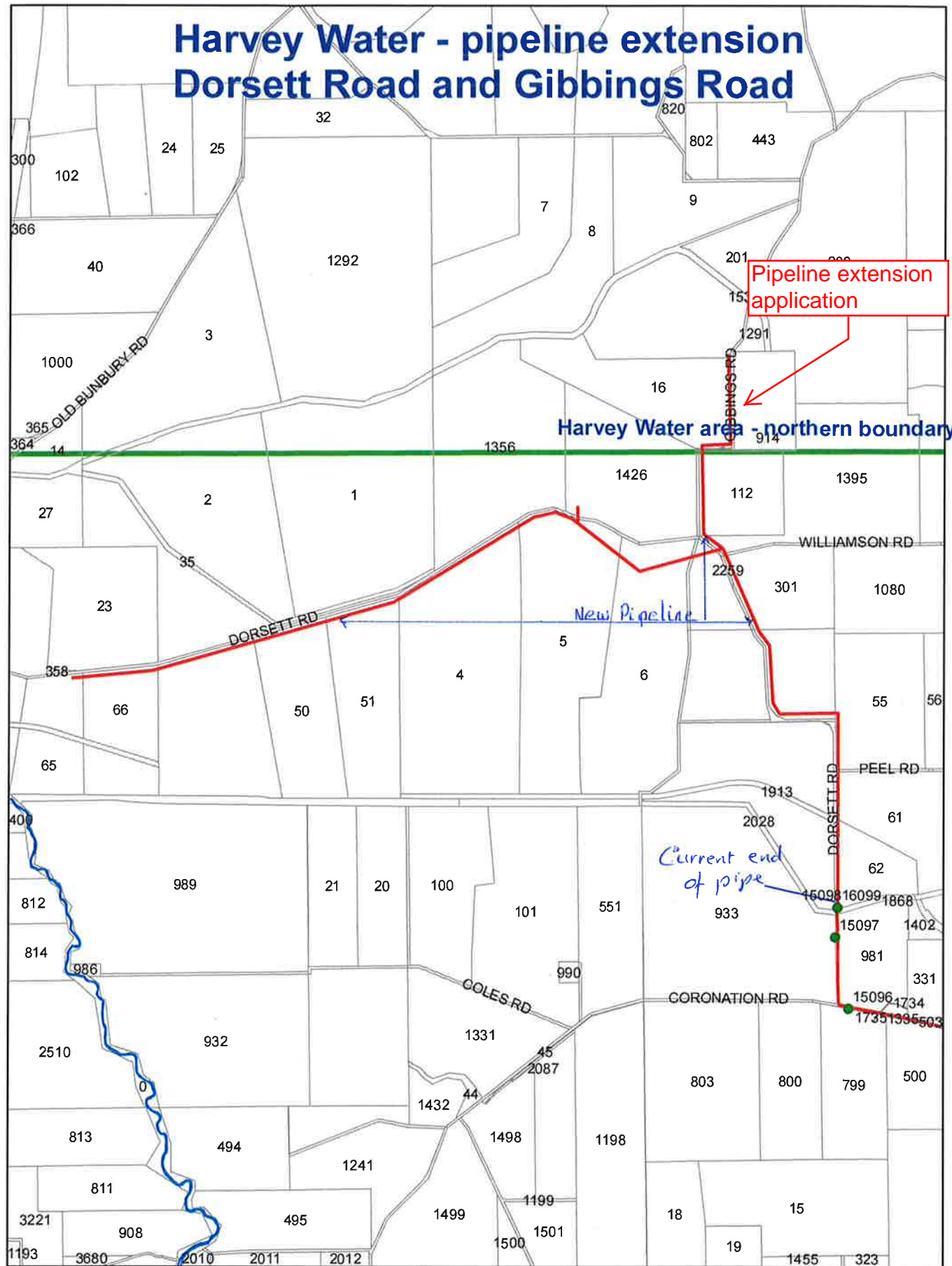
