**Case Statement**

- 1 By 2 November 2020 the Applicant is to file and serve:
  - (a) an amended statement of facts, issues and principal contentions;  
and
  - (b) any further lay evidence it intends to rely upon.

**Evidence**

- 2 The orders made by the Electricity Review Board on 20 July 2020 be amended so that:

- (a) Order 7 is deleted.
- (b) Order 8 is deleted
- (c) Order 9 is deleted.
- (d) Order 10 is deleted.
- (e) Order 11 be amended to read:

*'By 20 November 2020, the Applicant is to file any expert evidence on which it intends to rely in the proceedings'*

- (f) Order 12 is deleted.

- 3 The orders made by the Electricity Review Board on 12 June 2020 be amended so that the date the Parties are to make any request to the Presiding Member to sign a summons on behalf of the Board which requires a Party or a third-party to produce before the Board any books, papers or documents or categories of any relevant books, papers or documents in relation to the proceedings be extended to 27 November 2020.
- 4 By 7 February 2021, the Respondent is to file any expert evidence on which it intends to rely in the proceedings.
- 5 By 15 March 2021, the Applicant is to file and serve any responsive evidence.
- 6 By 26 March 2021, the experts retained by the Parties are to prepare a joint report setting out the matters on which they are agreed, the matters about which they disagree and a short statement of each expert's reasoning on the points of dispute.

### **Hearing**

- 8 The hearing listed for 15 February 2012 be vacated.
