Harvey Water believes that as the licence specifically includes the opportunity to provide irrigation services and the provision of non-potable water, there is no need to amend the licence for the purpose.

We are applying to amend the area in which those irrigation and non-potable services can be supplied. The company has been receiving expressions of interest from farmers and industry located along Nicholson Rd and Burnside Rd in Coolup extending as far as the town of Pinjarra (public open space) and Alcoa of Australia in Pinjarra

Harvey Water would appreciate assistance with the drawing of an amended licensed area. We agree to the services of Landgate being used for the purpose of re-drawing the area boundaries.

The following briefly addresses the information required for a licence application as described in Section 5 of your Guideline document. Please note that our website at <u>www.harveywater.com.au</u> provides a great deal of this information as well. Should you require it in full and in hard copy for the purposes of this application, then we shall be pleased to do so.

#### FINANCIAL INFORMATION.

As per our annual reports on our website and from ERA Audits previously carried out. The 2020-21 reports will be sent to you by the end of September 2021.

Harvey Water will develop further infrastructure to meet new demands for water. New pipelines will be financed jointly with major customers.

#### TECHNICAL INFORMATION

Physical environment is as currently exists except that we are seeking the opportunity to potentially supply farmlands to the north of Coolup and industry in Pinjarra.

Utility Supply. Harvey Water will use both its present water delivery system and new purpose built pipelines to supply customers with irrigation and non-potable water services.

Construction Activities. Harvey Water will build a pipeline dedicated to the delivery of water to farms and industry along Nicholson Rd Coolup, Burnside Rd Meelon, Napier Road Pinjarra and through to the Fairbridge, North Dandalup area.

Technical Ability. Harvey Water has over 20 years experience in the delivery of water to farms through our own pipeline system.

Asset Management System. The ERA has audited Harvey Water several times since 1996, and is well supplied with information on our asset management system which we believe to be of a high standard.

#### PUBLIC INTEREST INFORMATION.

Harvey Water has a record of showing initiative to develop new ways of effectively managing water resources and this proposed amendment is another example. We believe there is a market and a proper place for the use of fit-for-purpose non-potable water which is complementary to the potable services normally provided by the main WA water supply agency. We are physically well placed to deliver good value services to the irrigation and non-potable markets and have the institutional capability of constructing and managing the supply systems.

There is major growth in the SW of WA. We have identified the need for up to 30 GL per year in the longer term. This must come from somewhere and it is our belief and proposal that we can provide some of this from Wellington dam and will continue to strongly support the improvement in water quality in the dam. Industrial growth will bring regional and employment growth which are strongly supported by Harvey Water.

There are no particular environmental considerations which are different from those already encountered and addressed with our current pipeline projects.

Our stock and garden 50mm supply service (RWS) will allow a constant supply of water under gravity head pressure to a large number of local rural dwellers on lifestyle

blocks of about 2 hectares. Currently these potential customers may have opportunistic water supplies from the Murray river, the superficial aquifer or other brooks. We believe that our service will be a major improvement for that group of customers.

This RWS service will also be available to the local community. Throughout our area we provide water to support bushfire brigades through direct supply points as well as adaptable air valves to facilitate fast refill. We also provide services to the shires for public open space and recreation.


