Harvey Water believes that as the licence specifically includes the opportunity to provide Non-Potable Water services, there is no need to amend the licence for that purpose.

We do wish to amend the area where those non-potable services pipeline traverses. Given our provision of non-potable water at the Kemerton Strategic Industrial Area (KSIA) and the treatment of this water for process purposes there is a volume of waste water that cannot be recycled and has to be disposed of. The volume of waste is less than 500ML per year however it is unsafe and uneconomical to dispose of this by truck in such a large volume. Harvey Water investigated evaporative solutions however these required a very high level of capital expenditure that could not be warranted for the volume and in addition to which the power requirement was very high and would have a negative impact on emissions. The solution retained is that of a brine ocean outfall pipeline developed for the KSIA. Harvey Water has designed the pipeline and has completed the environmental approval process including self-referral to the EPA. The EPA recommendation has now been submitted for ministerial approval.



Harvey Water has submitted a development application to the Shire of Harvey the outcome of which is expected in early May. Given the approaching autumn and winter seasons Harvey Water applied to the EPA and the Shire, for approval to complete early works in December 2021. Approval was granted and currently these early works in the low lying sections of the pipe route west of the Forrest Highway are 85% complete.

The project schedule has the pipeline commissioned in July 2022 in time for the ramp up of production at the Albemarle Lithium Refinery in Kemerton.

Harvey Water would appreciate assistance with the drawing of an amended licensed area. We agree to the services of Landgate being used for the purpose of re-drawing the area boundaries.

Corporate Information

Financial Information

As per our annual reports on our website and from ERA Audits previously carried out.

Harvey Water will self-fund the construction of this infrastructure. The funds will be drawn down from existing invested funds

Technical Information

Utility Supply - Harvey Water will use both its present water delivery system and new purpose built pipelines to supply customers.

Construction Activities - Harvey Water will build a pipeline to convey brine waste from the KSIA to the designated point of diffusion in the Indian Ocean approximately 11kms west of the KSIA and 500m offshore south of Binningup.

Technical Ability - Harvey Water has over 20 years' experience in the construction of pipelines in the area. Given the nature of the water product in this pipeline Harvey Water has included flow meters and instrumentation for early leak detection and location identification. The specialist ocean outfall installation will be carried out by an expert directional drilling contractor and marine team.

Asset Management System - The ERA has audited Harvey Water several times since 1996, and is well supplied with information on our asset management system which we believe to be of a high standard.



Public Interest Information

Harvey Water has a record of showing initiative to develop new ways of effectively managing water resources and services. This proposed amendment is another example. Harvey Water has enabled the Kemerton Strategic Industrial Area (KSIA) through the provision of non-potable water for industrial purposes and we have added value by treating the water for process purposes. By constructing this brine waste pipeline Harvey Water is further enabling the KSIA by ensuring that other customers will be able to manage treated brine waste water from their operations through the pipeline provided that the discharge remains within the parameters agreed in the EPA licence. Harvey Water is confident that this enabling infrastructure will support industrial growth in the KSIA further developing regional and employment growth.


