Technical Rules 2016; Clause 3.2.1(d)(2)	<p>Negative phase sequence voltage</p> <p><i>Technical Rules (Rules) clause 3.2.1(d)(2) requires Users directly connected to the transmission system to be connected to all three phases. Where a User proposes a two-phase connection, Western Power requires a Rules exemption request to be submitted. The exemption request is to be supported by information and analysis to enable a determination as to whether the conditions detailed below, can be met.</i></p> <p><i>The information and analysis provided as supporting information for the exemption request needs to demonstrate that the continuous operation of the nominated connection point, with the cl. 3.2.1(d)(2) exemption in place, will not:</i></p> <ol style="list-style-type: none"> <i>1. adversely affect the power system stability or security; and</i> <i>2. impact the quality of supply or reliability for other network Users; and</i> <i>3. breach the limits set out in cl. 2.3.5 of the Rules.</i> <p>An exemption application for each qualifying connection point is still required.</p> <p>(Refer to https://westernpower.com.au/media/2806/technical-rules-conditional-exemption-notification-clause-321d2-two-phase-supply.pdf)</p>

Technical Rules 2016; Clause 3.6.7.2(a)	<p>Under this exemption, the Rules clause 3.6.7.2(a) is modified for the specified location only, and it now states:</p> <p>3.6.7.2 (a)</p> <p>“Each <i>facility</i> at which a <i>generating unit</i> in a small <i>power station</i> is connected to the <i>distribution system</i> must contain one main switch provided by the <i>User</i> for each <i>connection point</i> and one main switch for each <i>generating unit</i>, where a <i>generating unit</i> shares a <i>connection point</i> with other <i>generating units</i> or <i>loads</i>. Alternative arrangements comprising of clearly labelled multiple main switches will be accepted, provided response to faults on the network or on the User’s installation is not adversely affected by this change. For larger installations, additional <i>connection points</i> and main switches or a dedicated feeder may be required.”</p>
