GTL LICENCE APPLICATION AND GDL 9 TRANSFER



## 4.1.1 Identification of the applicant and a description of the applicant's structure and key organizational relationships.

Application to obtain the approval of the Economic Regulation Authority ABN 96 646 258 286 (ERA) for (i) the grant of a Gas Trading Licence (GTL), and (ii) the transfer by Wesfarmers Kleenheat Gas Pty Ltd ACN 008 679 543 (Kleenheat) of its Gas Distribution Licence (GDL9), to Supagas Pty Limited ABN 50 074 008 496 (Supagas).

The issue of the GTL and transfer of GDL9 is required in connection with the proposed acquisition by Supagas of Kleenheat's LPG distribution business (**Acquisition**).

Supagas is an Australian company registered under the Corporations  $Act\ 2001$  as a proprietary company limited by shares.

Taiyo Nippon Sanso Corporation (TNSC) acquired Supagas in 2016. TNSC is listed on the Tokyo Stock Exchange.

Supagas had approximately 1,100 full-time equivalent employees as of 30 June 2024.

#### 4.1.2 A description of the proposed licensed service(s).

GDL9 relates to what would, after the Acquisition, be Supagas's operations as a supplier of gas from Liquified Petroleum Gas (**LPG**) distribution systems that it owns and operates in Albany, Margaret River and Leinster.



The GTL is required in relation to what would, after the Acquisition, be Supagas's operations as a gas retailer in the Coastal and Great Southern gas supply areas. These retail operations relate to the distribution of LPG to small use customers via Supagas's LPG distribution systems in Albany and Margaret River.

#### 4.1.3 A description of any service infrastructure/works involved.

As part of the Acquisition, Supagas will acquire from Kleenheat the personnel, assets, licences and approvals necessary to carry on the LPG distribution business. Supagas intends to utilise Kleenheat's know-how and other intellectual property relating to reticulated LPG supply, including the terms of the Kleenheat standard form customer contract.

The Acquisition will assist Supagas better service its customers in Western Australia. With the acquisition of the Kleenheat distribution and branch network, it positions Supagas to accelerate its next stage of growth, enabling an expansion of its product offering and delivery footprint for its customers. Supagas currently has an established presence in Western Australia with a branch in Perth and a gas manufacturing facility in Karratha.

#### 4.1.4 A description of the licence operating area(s) for the proposed licensed services.

The supply areas for GDL9 will be the Coastal, Great Southern and Goldfields-Esperance supply areas.

The supply areas for the GTL will be the Coastal and Great Southern supply areas.

These licences will allow the Acquisition to proceed and for Supagas to continue providing services to the relevant customers on terms consistent with Kleenheat's current LPG distribution business.

Supagas operates in the Dangerous Goods industry, holds numerous Dangerous Goods licences, and operates 2 Major Hazard Facilities. Based on the above, Supagas believes the issue of the GTL and transfer of GDL9 should occur and will not be contrary to the public interest.
