THE WESTERN AUSTRALIAN GAS REVIEW BOARD ORDERS THAT:

- 1 On or before **25 February 2011**, the Applicants file and serve a statement of issues facts and contentions, together with a written outline of submissions, in relation to their respective applications.
- 2 On or before **14 March 2011**:
 - (a) BHP file and serve a statement of issues facts and contentions, together with a written outline of its submissions in reply in File No. 2 of 2010;
 - (b) the GGTJV and GGT file and serve a statement of issues facts and contentions, together with a written outline of its submissions in reply in File No. 1 of 2010.
- 3 On or before **25 March 2011**, the Economic Regulation Authority file and serve a statement of issues facts and contentions together with a written outline of its submissions in Files No. 1 and 2 of 2010.
- 4 On or before **4 April 2011**, the Applicants file and serve a written outline of any submissions in reply to the materials provided pursuant to orders 2 and 3.
- 5 On or before **8 April 2011**, the Applicants, in consultation with the Economic Regulation Authority and the Registrar, prepare a review book index to include:
 - (a) the applications for review;
 - (b) all submissions on the applications; and
 - (c) a copy of all documents to be relied on by the parties.
- 6 On or before **12 April 2011**, the Applicants file and serve the review book.
- 7 The matters be listed for hearing for four days on **18 April 2011 to 21 April 2011** (inclusive).
- 8 There be liberty to apply.
