Horizon Power requests that licence EIRL 2 be amended to record the following licence boundary change:

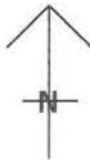
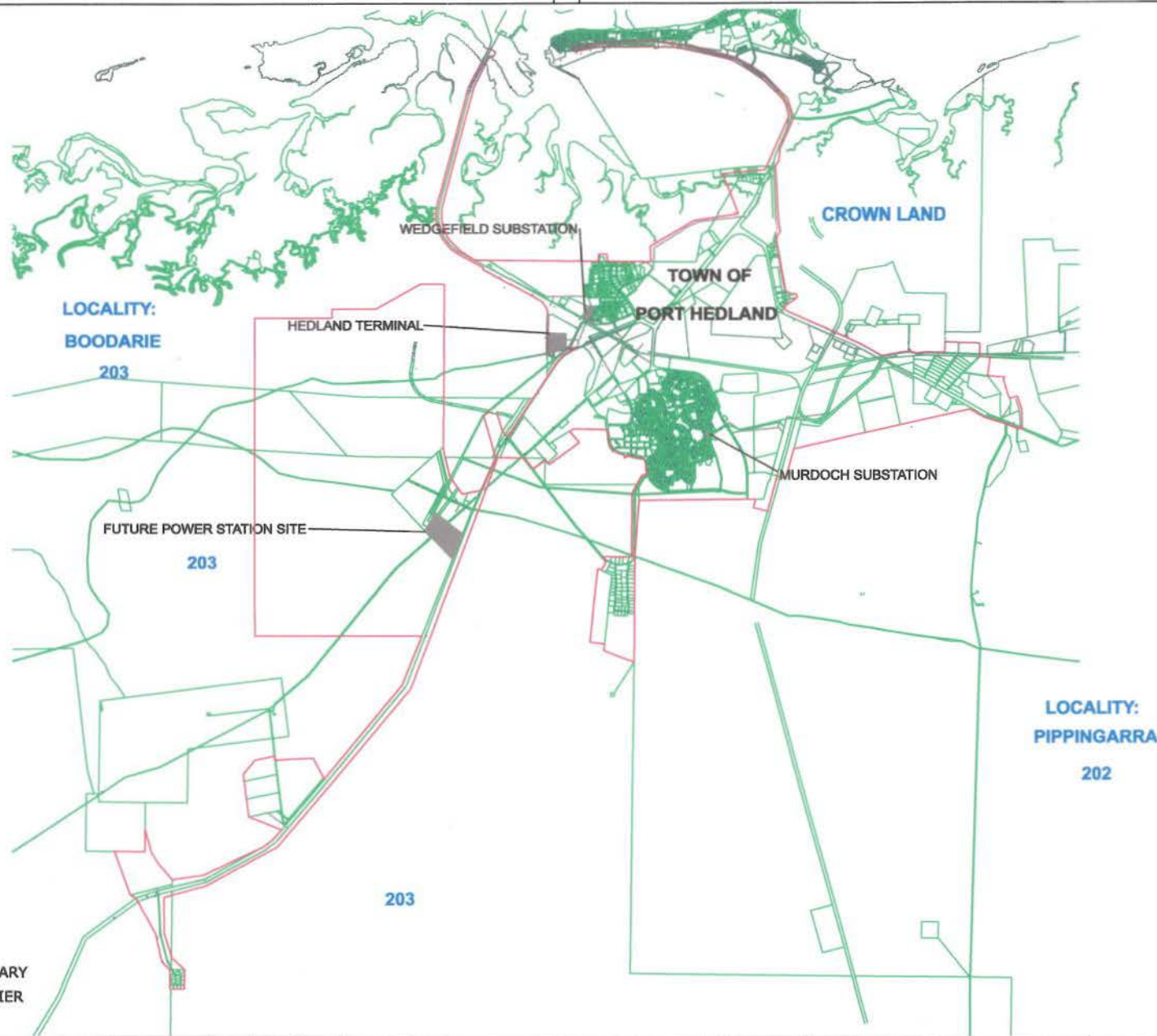

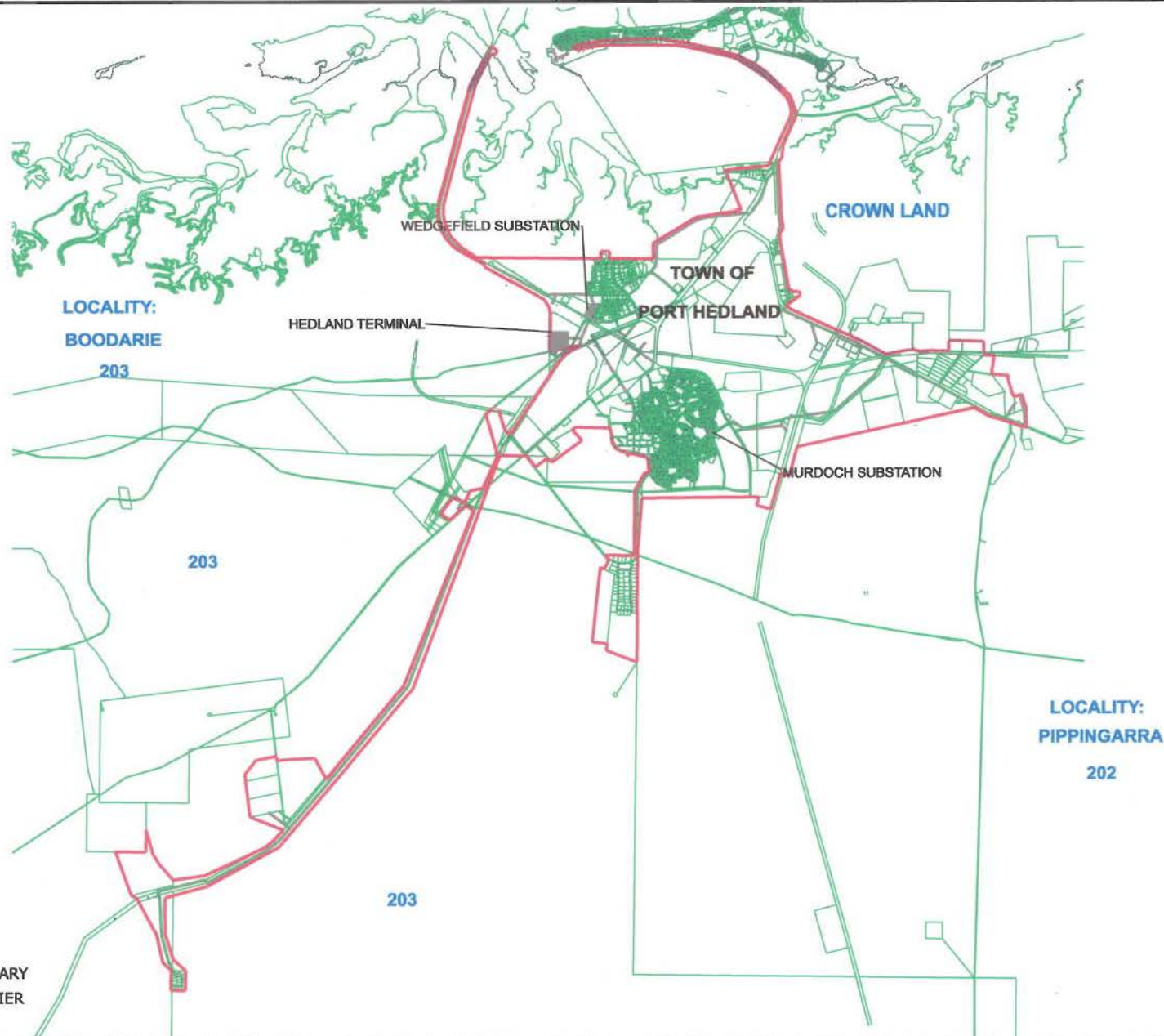
